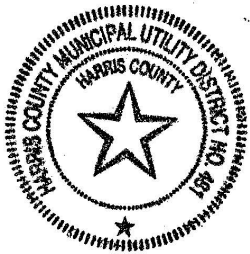

3. Engineering matters related to projects, improvements, or services for the District, including:
 - a. authorization for design;
 - b. approval of plans and specifications and authorization for competitive bids or proposals;
 - i. water, sewer, and drainage facilities to serve Edgewater, Section PA 14 1A;
 - ii. water, sewer, and drainage facilities to serve Edgewater, Section PA 14 1B; and
 - iii. water, sewer, and drainage facilities to serve Edgewater, Water Street extension
 - iv. water, sewer, and drainage to serve Marina View extension;
 - v. paving and appurtenances to serve Marina View Drive extension; and
 - vi. lift station no. 2
 - c. approval of contracts, letter financing agreements, or cost sharing agreements;
 - d. approval of pay estimates, change orders, and final acceptance as appropriate, for projects in the service area;
 - e. deeds and easements;
 - f. utility conveyances to City of Webster; and
 - g. maintenance of drainage channels.
